**Sub: Inviting Expression of Interests (EoIs) for Empanelment of Suppliers for supply of Electronic Jacquard with motorized lifting device (as one unit) & Motorized lifting device for jacquard (Single Lever) to the weavers of different district of Gujarat State inside/ outside Cluster Development Programme, under National Handloom Development Programme (NHDP).**

- 1 Weavers' Service Centre (WSC), O/o Development Commissioner for Handlooms, Ministry of Textiles, Government of India, Ahmedabad invites online bids from the interested entities through two bid system (Technical and Financial) for supply of Electronic Jacquard with motorized lifting device (as one unit) & Motorized lifting device for jacquard (Single Lever) to the weavers in the districts of **Gujarat State** under National Handloom Development Programme (NHDP) where the 90% of the cost will be borne by the Ministry of Textiles, GoI (O/o The Development Commissioner for Handlooms, New Delhi) and 10% will be borne by the respective weaver. The main object of empanelment of the entities as approved suppliers is to have a broad-based panel of technically capable, financially sound and reliable suppliers.
- 2 The tender document may be downloaded from the CPP portal [www.eprocure.gov.in/eprocure/app](http://www.eprocure.gov.in/eprocure/app), but online bids must be submitted through CPP Portal [www.eprocure.gov.in/eprocure/app](http://www.eprocure.gov.in/eprocure/app). **Offline/Manual bids will not be accepted.** Bidders are advised to follow the instructions provided in the enclosed Request For Proposal (RFP). 3. Bid documents may be scanned with 150 dpi with Black and white option which helps in reducing size of the scanned document. **All the technical bid documents may be scanned followed by page by page in to a single PDF file.**

4. Bidders shall not tamper/modify the tender form including downloaded financial bid template in any manner. In case if the same is found to be tampered/modified in any manner, tender will be completely rejected and EMD would be forfeited and bidder will be blacklisted from doing any business with WSC, Ahmedabad.

5. Bidders are advised to visit the websites of [www.handlooms.nic.in](http://www.handlooms.nic.in) and CPP portal ([www.eprocure.gov.in/eprocure/app](http://www.eprocure.gov.in/eprocure/app)) regularly till closing date of submission of tender for any corrigendum/addendum/amendment.

6. **Public Procurement (Preference to Make in India):**

I) The provisions of Public Procurement (Preference to Make in India) Order 2017 issued by Department of Industrial Policy and Promotion under Ministry of Commerce and Industry vide order no. P-45021/2/2017BE-II, dated 15.06.2017 shall be applicable to the bidding process and award of the contract shall be done accordingly. In this connection, the minimum local content shall be 50% and the margin of purchase preference shall be 50%. The bidder shall have to specify whether he is a local supplier in terms of the Public Procurement (Preference to Make in India) Order 2017 or otherwise in the bid and they have also to sign the **Annexure VII to be provided on a non-judicial stamp paper of Rs. 100/-.**

III) It may be noted that as this is an empanelment and all the bidders who matches with L1 will be empanelled, but as per the conditions laid down in the Para 3(a)/3 (b)/ 3(c) (whichever is applicable) of the of the Public Procurement (Preference to Make in India) Order 2017, purchase preference of 50% shall be given among local suppliers who are empanelled as they matched with L1.

7. **Relaxation for Micro & Small Enterprises (MSEs):**

As per the Government Policy Circular No. 1(2) (1)/2016-MA, Dated 10.03.2016 issued by O/o Development Commissioner (MSME), Ministry of Micro, Small, & Medium Enterprises, Government of India, Micro and Small Enterprises (MSEs) are exempted from prior turnover and prior experience in all public procurements subject to meeting of quality and technical specifications. The bidders need to submit the copy of Certificate of Registration for Micro or Small Enterprises (Udyam Registration Certificate) issued by Ministry of Micro, Small and Medium Enterprises (MSME), Govt. of India or equivalent for claiming this exemption for prior turnover and experience.

8. **Relaxation for Start -up companies:**

As per the Office Memorandum No. F.20/2/2014-PPd (Pt.) dated 25.06.2016 issued by Department of Expenditure, Ministry of Finance, Government of India, Start-up companies shall be exempted from prior turnover and prior experience in all public

procurements subject to meeting of quality and technical specifications. The bidders need to submit the copy of Start-up India Registration Certificate issued by Department of Promotion of Industry and Internal Trade, Ministry of Commerce and Industry, Govt. of India or equivalent for claiming this exemption for prior turnover and experience.

9. **Earnest Money Deposit (EMD) & BID – Securing Declaration:**

I) **BID – Securing Declaration:**

As per GFR 2017 & the recent Guidelines issued by Government of India, in lieu of Bid Security (EMD), bidders (if applicable) are asked to sign the “Bid Security Declaration” accepting that if they withdraw or modify their bids or fail to produce the Performance Guaranty as per the Orders given, during the period of validity etc., they will be suspended for the time specified in the tender documents, in case of this tender it is fixed as three Years. As such the bidders have to sign the **Annexure III of the RFP to be provided on a non-judicial stamp paper of Rs. 100/-.**

### Request for Proposal for Empanelment of Suppliers for supply of Electronic Jacquard with motorized lifting device (as one unit) & Motorized lifting device for jacquard (Single Lever) to the weavers under Hathkargha Samvardhan Sahayata (HSS) under National Handloom Development Programme (NHDP).

#### 1. Background

The Handloom sector is the second largest employer in India. This sector is unorganized and dispersed. For improving the quality of the fabric and enhancing the productivity, Ministry of Textiles is providing financial assistance to the Handloom weavers for Technological up-gradation of handlooms by providing **Electronic Jacquard with motorized lifting device (as one unit) & Motorized lifting device for jacquard (Single Lever)** under Hathkargha Samvardhan Sahayata (HSS) under NHDP. The Office of DC (Handlooms) is taking up-gradation of handlooms under National Handloom Development Programme (NHDP).

Government of India will provide financial assistance to the extent of 90% of the cost of **Electronic Jacquard with motorized lifting device (as one unit) & Motorized lifting device for jacquard (Single Lever)** and remaining 10% will be borne by the weavers. [Accordingly, it has been decided to invite technical and financial bids on the basis of scope of work and eligibility criteria.]

New guidelines of National Handloom Development Programme (NHDP) issued by office of DC (Handlooms) are available on the website [www.handlooms.nic.in](http://www.handlooms.nic.in)

#### 2. Empanelment of Suppliers

For supply of identified items in **Annexure –I**, Expression of Interests (EoIs) are invited from interested entities suppliers/manufacturers of **Electronic Jacquard with motorized lifting device (as one unit) & Motorized lifting device for jacquard (Single Lever)**.

#### 3. Scope of Work

To supply specified quality **Electronic Jacquard with motorized lifting device (as one unit) & Motorized lifting device for jacquard (Single Lever)** to the applicants (weavers) as per the specifications mentioned in the RFP and the supply order, within 2 months of receipt of their 10% financial contribution. Supplier shall ensure delivery & installation of **Electronic Jacquard with motorized lifting device (as one unit) & Motorized lifting device for jacquard (Single Lever)** with prior intimation to weavers/beneficiaries through SMS/Letter/Phone/E-mail/etc. (address and phone numbers will be provided with the Supply Order)

#### 4. Electronic Jacquard with motorized lifting device (as one unit) & Motorized lifting device for jacquard (Single Lever) Specifications and terms & conditions.

- The items supplied should be new, of good quality and comply with the parts specifications and quality norms as attached in **Annexure – I**.
- A sample of items shall be submitted as per para no.6(d)(xi) of RFP to the Weavers' Service Centre, Ahmedabad.
- Supplier needs to stamp/emboss/engrave all the items supplied by him with a unique code for identification. Quality of item will be checked by weaver at the time of taking delivery and has to fulfil the weavers' satisfaction.
- **Any deviations found from approved specification and quality of the items will result in cancellation of the order and supplier should take back his material at his/their own cost.**

- All items in **Annexure-I** should carry a warranty of minimum **one year** against any manufacturing defects from date of Installation/ Commissioning. In addition to this in respect of item no.1 to 4 of **Annexure-I**, basic training in use of **Electronic Jacquard with motorized lifting device (as one unit) & Motorized lifting device for jacquard (Single Lever)** and three years Free Service also to be provided by the supplier. If the supplier failure to comply with warranty/ Service obligations will result in forfeiture of the performance security. Further, they may also black listed from participation in other Government Tenders.

#### **5. Eligibility Criteria for submission of EoI**

- a) The Supplying entity should be a registered entity/agency.
- b) The entity must have GST registration.
- c) The Supplying entity should have minimum two years' experience in manufacturing / supplying of the Electronic Jacquard with motorized lifting device (as one unit) & Motorized lifting device for jacquard (Single Lever) for which bids are submitted.

#### **6. Public Procurement (Preference to Make in India):**

The purchase preference (Preference to Make in India) as mentioned in para No. 6 (I), (II) & (III) of this tender document, if applicable will be carried by the evaluation committee.

**8. Relaxation for Start -up companies:** As per para No.8 of this tender document.

**9. Bid Security (EMD):** As per para No.9 (I) & (II) of this tender document.

#### **10. Information to the Bidders on E-tendering**

Online bids must be submitted through CPP Portal [www.eprocure.gov.in/eprocure/app](http://www.eprocure.gov.in/eprocure/app).

**Offline/Manual bids will not be accepted.** Except EMD, Samples, Catalogues, Photographs of items.

**Detailed Process to Registration/Search/Preparation/Submission of the tender through the following process:**

The bidders are required to submit soft copies of their bids electronically on the CPP portal, using valid Digital Signature Certificates. The instructions given below are meant to assist the bidders in registering on the CPP portal, prepare their bids in accordance with the requirements and submitting their bids online on the CPP portal. More information useful for submitting online bids on the CPP portal may be obtained at <http://eprocure.gov.in/eprocure/app>.

##### **a) Registration:**

- i. Bidders are required to enroll on the e-Procurement module of the Central Public Procurement Portal (URL: <http://eprocure.gov.in/eprocure/app>) by clicking on the link "Click here to Enroll". Enrolment on the CPP Portal is free of charge.
- ii. As part of the enrolment process, the bidders will be required to choose a unique username and assign a password for their accounts.
- iii. Bidders are advised to register their valid email address and mobile numbers as part of the registration process. These would be used for any communication from the CPP Portal.

- iv. Upon enrolment, the bidders will be required to register their valid Digital Signature Certificate (DSC) (Class II or class III Certificates with signing key usage) issued by any certifying Authority recognized by CCA India (e.g.Sify/TCS/nCode/eMudhra etc.), with their profile.
- v. Only one valid DSC should be registered by a bidder. Please note that the bidders are responsible to ensure that they do not lend their DSCs to others which may lead to misuse.
- vi. Bidders then log in to the site through the secured log-in by entering their user ID/Password and the password of the DSC/ e-Token.

**b) Searching of Tender Documents:**

- i. There are various search options built in the CPP Portal, to facilitate bidders to search active tenders by several parameters. These parameters could include Tender ID, Organization Name, Location, Date, Value etc. There is also an option of advanced search for tenders, wherein the bidders may combine a number of search parameters such as Organization Name, Form of Contract, Location, Date, Other keywords etc. to search for a tender published on the CPP Portal.
- ii. Once the bidders have selected the tenders they are interested in, they may download the required documents/ tender schedules. These tenders can be moved to the respective 'My Tenders' folder. This would enable the CPP Portal to intimate the bidders through SMS/email in case there is any corrigendum issued to the tender document.
- iii. The bidder should make a note of the unique Tender ID assigned to each tender, in case they want to obtain any clarification/ help from the Helpdesk.

**c) Preparation of Bids**

- i. Bidder should take into account any corrigendum published on the tender document before submitting their bids.
- ii. Please go through the tender advertisement and the tender document carefully to understand the documents required to be submitted as part of the bid. Please note the number of covers in which the bid documents have to be submitted, the number of documents including the names and content of each of the document that need to be submitted. Any deviations from these may lead to rejection of the bid.
- iii. Bidder, in advance, should get ready the bid documents to be submitted as indicated in the tender document / schedule and generally, they can be in PDF/ XLS / RAR /JPG formats. Bid documents may be scanned with 150 dpi with black and white option which helps in reducing size of the scanned document.
- iv. To avoid the time and effort required in uploading the same set of standard documents which are required to be submitted as a part of every bid, a provision of uploading such standard documents (e.g. PAN Card copy, audited balance sheet, GST registration, etc.) has been provided to the bidders. Bidders can use "My Space" or "Other important Documents" area available to them to upload such documents. These documents may be directly submitted from the "My Space" area while submitting a bid and need not be uploaded again and again. This will lead to a reduction in the time required for bid submission process.

**d) Submission of Bids**

- i. Bidder should log into the site well in advance for bid submission so that he/she can upload the bid on time. i.e. on or before the bid submission time. Bidder will be responsible for any delay due to other issues.
- ii. The bidder has to digitally sign and upload the required bid documents one by one as indicated in the tender document.
- iii. The bidder has to select the payment option as “offline” to pay the EMD as applicable and enter details of the instrument.

The Bidder should prepare the EMD as per the instructions specified in the tender document. The original should reach the concerned official of the WSC, Ahmedabad latest by the closing date and time of submission of bids. The details of the DD, physically sent, should tally with the details available in the scanned copy and the data entered during bid submission time. Otherwise the uploaded bid will be rejected.

**Important Note:**

- Micro and Small Enterprises registered for stores specified in the tender are exempted from payment of earnest money only on the submission of MSME registration certificate, ( If applicable)This exemption is valid only if the Bidder submits a proof of UAM number allotted them.
  - The Start-up companies who wish to claim EMD exemption prior turnover and experience need to submit the copy of Start-up India Registration Certificate issued by Department of Promotion of Industry and Internal Trade, Ministry of Commerce and Industry, Govt. of India.
- iv. A standard Bill of Quantity (BoQ) format for financial bid has been provided with the tender document to be filled by all the bidders. Bidders are requested to note that they should necessarily submit their financial bids in the BoQ format provided and no other format is acceptable. Bidders are requested to download the BoQ file, open it and complete the sky blue coloured (unprotected) cells with their respective financial quotes and other details (Such as name of the bidder). No other cells should be changed. Once the details have been completed, the bidder should save it and submit it online, without changing the filename. If the BoQ file is found to be modified by the bidder, the bid will be rejected.
  - v. The server time (which is displayed on the bidder’s dashboard) will be considered as the standard time for referencing the deadlines for submission of the bids by the bidders, opening of bids etc. The bidders should follow this time during bid submission.
  - vi. All the documents being submitted by the bidders would be encrypted using PKI encryption techniques to ensure the secrecy of the data. The data entered cannot be viewed by unauthorized persons until the time of bid opening. The confidentiality of the bids is maintained using the secured socket layer 128-bit encryption technology. Data storage encryption of sensitive fields is done. Any bid document that is uploaded to the server is subjected to symmetric encryption using a system generated symmetric key. Further this key is subjected to asymmetric encryption using buyers/bid openers public keys.
  - vii. The uploaded tender documents become readable only after the tender opening by the authorized bid openers.
  - viii. Upon the successful and timely submission of bids (i.e. after clicking “Freeze Bid Submission” in the portal), the portal will give a successful bid submission message & a bid summary will be displayed with the bid no. and the date & time of submission of the bid with all other relevant details.



- ix. The bid summary has to be printed and kept as an acknowledgement of the submission of the bid. This acknowledgement may be used as an entry pass by the bidder or his authorized signatory or his authorized representative (the authorized representative must carry the authorization letter signed by the bidder or his authorized signatory) for any bid opening meetings.
- x. The online bids both Technical Bid and Financial bid duly furnished in COVER-I & COVER-II respectively should be uploaded by the due date and time as per the schedule given in Critical Date Sheet. **Tenders should not be submitted offline.**
- xi. A Sample of items [**Electronic Jacquard with motorized lifting device (as one unit) & Motorized lifting device for jacquard (Single Lever)**] shall be submitted in physical form OR in case the device is heavy/bulky, the supplier have the option to send the video of the device in running conditions demonstrating the complete working process of the device along with the exact specification (brochure, etc.) in printed form to WSC, Ahmedabad on or before the closing date and time of submission of bids for demo and evaluation.

**Note: The suppliers have to supply the exact items as per specifications if he/she chooses to demonstrate the items in physical or video form. There should not be any deviation.**
